Whereabouts win for the UCI

Spain's Carlos Roman Gorbano loses privacy battle

The UCI has won a key legal battle in defence of the Whereabouts Information System it uses to carry out urine tests out of competition anti-doping tests.

In a press release issued on Monday, the UCI announced that a provincial court in Almeria, Spain, had rejected the appeal by Carlos Roman Gorbano, who had challenged the legitimacy of the Whereabouts Information System.

The decision confirmed a sentence issued in 2007 when a judge ruled that the implementation of the whereabouts programme does not breach individual rights guaranteed by the Spanish Constitution, in particular in respect of the protection of privacy.

UCI President Pat McQuaid claimed the ruling helped the fight against doping.

"Cycling has been at the forefront of the fight against doping for many years. We are once again proud that our commitment offers benefits to the sports movement as a whole," he said. "We are ever more convinced that our joint efforts against the scourge of doping will become increasingly effective, in particular as a result of rulings such as this, which recognise the basic principles upon which our strategies and actions are based."

The UCI thanked the Spanish Cycling Federation (RFEC) and the World Anti-Doping Agency (WADA) for playing an important part in the case.

Team sports must play by 'whereabouts' rule - WADA

LAUSANNE, Switzerland (AFP) - World anti-doping chiefs insisted on Tuesday that all team sports, without exception, must play by rules obliging some athletes to announce their whereabouts for out-of-competition testing.

"There has been no exception for any federation," said World Anti-Doping Agency (WADA) Director General Alan Howell.

World football's governing body FIFA had raised qualms about the revised world anti-doping code introduced for all sports early last year, claiming that footballers should be granted special treatment.

The rulebook requires that designated athletes in all sports should give notice of their whereabouts for one hour a day, 365 days a year, to ensure that doping control officials can carry out random out of competition testing.

Howell said a misunderstanding with FIFA over the 'whereabouts' requirement had been cleared up in a series of meetings through 2009.

No other team sports had directly asked WADA for exemptions, he added.

"And if we received one we would say no," Howell added.

WADA is about to review the record of all sports in the fight against doping, including football, with a conference with international federations due in Lausanne in April to discuss the issue.

KRITERIJUMI ZA UKLJUČIVANJE U RTG(1)

- ❖ Nacionalna RTG bi trebalo da uključuje:
 - ✓ Sportiste nad kojim NADO ima nadležnost a koji su članovi internacionalnih RTG
 - ✓ Sportiste koji su članovi nacionalnih timovi na Olimpijskim i Paraolimpijskim igrama ili drugih sportova visokog nacionalnih prioriteta
 - ✓ Sportiste koji treniraju nezavisno, ali učestvuju na olimpijskom ili svetskom nivou
 - ✓ Sportiste koji su u periodu zabrane takmičenja
 - ✓ Sportiste koji su se povukli dok su bili u RTG i hoće da se vrate takmičenju
 - ✓ bilo kog sportistu kojeg ADO targetuje za kontrolu (ako sportiste treniraju ljudi koji su bili umešani u doping afere; ako neka treća strana javi da je sportista potencijalno umešan u neku doping aktivnosti; sportiste koji su postigli značajan i neočekivan uspeh...)

- ❖ U individualnim sportovima, RTG bi trebalo da uključi:
- ❖ Osvajače medalja na najskorijim Olimpijskim igrama ili Svetskim takmičenjima
- ❖ Najbolje rangirane sportiste svake discipline ili težinske kategorije
- ❖ Dodatne sportiste iz disciplina gde bi doping imao posebnu korist
- ❖ Sportiste čiji su uspesi u najboljih 5/10/20 u prethodnoj godini
- ❖ U timskim sportovima RTG može da obuhvata neke sportiste iz tima ili ceo tim...

OBAVEZE SPORTISTA KOJI SU ČLANOVI RTG



- Sportisti u RTG moraju da podnose whereabouts *kvartalno*
- Whereabouts je *obrazac o lokaciji* koji popunjavaju članovi RTG
- Obrasci o lokaciji se unose u *ADAMS* bazu podataka
- ADAMS je centralizovan sistem za unos, čuvanje i pristup podacima iz celoga sveta. Služi za komunikaciju između sportista, NADO, IF, NF, WADA i laboratorije

Anti-Doping Administration & Management System

- ❖ Odgovorna ADO je obavezna da ustanovi sistem koji obezbeđuje da su podaci sportiste iz RTG uskladišteni sigurno i da informacije mogu biti dostupne autorizovanim individuuama odgovorne antidoping organizacije i WADA
- ❑ Sistem mora da:
 - ✓ bude u saglasnosti sa Internacionalnim Standardom za zaštitu privatnosti i zaštitu podataka
 - ✓ uključi mehanizam za uredno i kompletno snimanje, prema pravilima skladištenja podataka
 - ✓ bude u elektronskoj formi i dostupan za pretraživanje drugim ADO
 - ✓ dozvoli praćenje informacija za inteligentne svrhe, npr. koliko često se dopunjava obrazac o lokaciji
 - ✓ Najjednostavniji način da se to uradi je da se koristi **ADAMS**

Povrede antidoping pravila vezane za W/A

- Neispunjavanje uslova u pogledu dostupnosti za testiranje izvan takmičenja:

1. Nedostavljanje podataka o boravištu - *filing failure*
2. Propuštanje testiranja - *missed test*

- ADAS daje izveštaj ko nije podneo whereabouts informacije.

- tri upozorenja-opomene u periodu od 18 meseci

- ADAS daje izveštaj ko nije bio dostupan za testiranje.

- tri neuspela pokušaja u periodu od 18 meseci

- Izveštaji se podnose sportisti, matičnom sportskom savezu i MOS-u



Tri propusta u roku od 18 meseci -

kazna od jedne do dve godine zabrane učešća u sportu!

KRITERIJUMI ZA NEPROCESUIRANJE OPOMENE

- Opravdani razlozi kada ne možemo da krivimo sportistu za nedostavljanje W/A:

- Bolest (akutna bolest)
- Tehnički problemi (greška u sistemu)
- Nemogućnost pristupa zbog geografskih poteškoća
- Porodične okolnosti (rođenje)
- Vremenske prilike i stanje na putevima
- Situacije izvan kontrole sportiste
- Vreme potrebno za edukaciji (ako je neko tek uključen u RTP ili se proces oko W/A menja)
- Greške zaposlenih u agenciji

- Registrovana test grupa je u 2010.godini smanjila svoj obim
- "Inteligentan" pristup odabiru sportista i sportova
- Od 185 sportista u 2009-oj do 110 sportista u 2010.godini
- 10 sportova
- Planirane OOC kontrole svih članova RTG



- Prema zahtevu MOK-a uključeni su svi kandidati za OG 2010.
- Sportisti koji su otišli na OG 2010 moraće svoje obrasce o lokaciji da popunjavaju sa izrazitom tačnošću zbog velikog broja nenajavljenih testiranja u Olimpijskom selu
- Dva propuštena testa za vreme trajanja OG, smatraće se povredom antidoping pravila!



Mišljenje sportista o W/A

... "to je cena koju plaća profesionalni sportista"



"It's the price you have to pay to be a professional athlete. If you want to have a clean sport you have got to sacrifice something. And I don't think that's a very big sacrifice compared to other jobs."

"For me it is really not a big problem because I have been working with such a system for many years, ever since I had my breakthrough internationally," said the 2004 and 2008 Olympic gold medalist. "We have been peddling the anti-doping code about where I was every day. I have kind of gotten used to it, so it is not a big deal. I have a very good team around me, and my coach sees the planning and since there's no such day, he posts online and lets them know I'm available for example from 7-8am every day."

"It is the possibility of it which is so important. Of course they will not come to test you every day; most athletes will be tested around 5-20 times out of competition. But most athletes know where they are going to be because of their training planning. I know three months in advance where I'm going to be. For me it was never a big deal."

"Sport is not a job like being a journalist or a construction worker. It is not the same in that sense. I think doping is cheating people out of their livelihood. If I go into a competition and somebody uses doping to beat me, they get my prize money. I'd like everyone to be clean but as long as it is possible to cheat, someone will cheat."
